## Abstrak

Kegiatan Praktik Kerja Profesi Apoteker (PKPA) di Rumah Sakit Universitas Indonesia bertujuan untuk memahami tugas, wewenang dan tanggung jawab apoteker dalam pelayanan farmasi klinik dan pengelolaan sediaan farmasi sesuai dengan peraturan perundang-undangan yang berlaku. Pelayanan kefarmasian di rumah sakit merupakan bagian yang tidak terpisahkan dari sistem pelayanan kesehatan Rumah Sakit yang berorientasi kepada pelayanan pasien, penyediaan sediaan farmasi, alat kesehatan, dan Bahan Medis Habis Pakai (BMHP) yang bermutu dan terjangkau. Apoteker memiliki peran penting dalam pengelolaan paket tindakan termasuk perencanaan, pengendalian, dan pengelolaan stok stok yang mencakup pengadaan, penyimpanan dan distribusi. Pengelolaan penyiapan paket tindakan Herniotomi Anak di Central Operating Theatre (COT) ditemukan adanya variasi kebutuhan jenis dan jumlah sediaan farmasi, alat kesehatan dan Bahan Medis Habis Pakai (BMHP) sehingga ketersediaan sediaan farmasi maupun Bahan Medis Habis Pakai (BMHP) belum optimal yang ditandai dengan adanya selisih penggunaan sediaan farmasi dan Bahan Medis Habis Pakai (BMHP) dengan paket tindakan yang telah disiapkan. Berdasarkan uraian di atas perlu diperlukan evaluasi kesesuaian antara paket tindakan yang telah disiapkan dengan penggunaannya secara aktual.

Internship at the University of Indonesia Hospital aims to understand the duties, authority, and responsibilities of pharmacists in clinical pharmacy services and management of pharmaceutical preparations in following applicable laws and regulations. Pharmaceutical services in hospitals are an inseparable part of a hospital health service system oriented towards patient service, providing quality and affordable pharmaceutical preparations, medical devices, and consumable medical materials. Pharmacists have an important role in managing action packages including planning, controlling, and stock management which includes procurement, storage, and distribution. Management of the preparation of pediatric herniotomy action packages at the Central Operating Theater (COT) found that there were variations in the need for types and quantities of pharmaceutical preparations, medical devices, and consumable medical materials, so the availability of pharmaceutical preparations and consumable medical materials was not optimal, as indicated by there is a difference in the use of pharmaceutical preparations and consumable medical materials with the action packages that have been prepared. Based on the description above, it is necessary to evaluate the suitability between the action packages that have been prepared and their actual use.
