

Peranan Majelis Pengawas Daerah Kota Depok dalam Menghadapi Permasalahan Pelanggaran Jabatan Notaris di Kota Depok = The Role of the Regional Supervisory Council of Depok City in Addressing Issues of Notary Position Violations in Depok City

Abstrak

Majelis Pengawas Daerah (MPD) berfungsi untuk melakukan pengawasan dan pembinaan terhadap jabatan Notaris. Peranan MPD sangat penting untuk meminimalisir pelanggaran jabatan Notaris secara khusus pada Kota Depok. Sehingga perlu diteliti mengenai peran MPD dalam menghadapi pelanggaran jabatan Notaris di Kota Depok berdasarkan ketentuan yang berlaku serta implikasi penanganan jenis laporan aduan pelanggaran yang dilaporkan oleh masyarakat pada kinerja MPD Kota Depok. Penelitian ini menggunakan metode non-doktrinal dengan data empiris yang kualitatif dengan metode wawancara dan didukung oleh data sekunder. Penelitian ini mengkaji mengenai kinerja pengawasan MPD di Kota Depok dan kesesuaiannya dengan peraturan serta teori terkait. Hasil penelitian menyimpulkan bahwa; (1) peranan MPD Kota Depok dalam menghadapi permasalahan pelanggaran jabatan Notaris di Kota Depok, yaitu melakukan pemeriksaan kepada Notaris yang bersangkutan berdasarkan pelanggaran yang ditemukan saat pemeriksaan protokoler dan pengaduan masyarakat serta pemeriksaan secara mendadak bagi Notaris yang dikategorikan sering melakukan pelanggaran di Kota Depok; (2) MPD Kota Depok telah berusaha menangani setiap laporan pengaduan yang dilaporkan dari tahun 2022 hingga 2024, namun masih terdapat hal yang perlu dievaluasi terkait ketertiban dalam administrasi, pengolahan data laporan aduan setiap tahunnya serta transparansi terhadap data laporan aduan yang ada di MPD Kota Depok.

.....The Regional Supervisory Council (MPD) functions to oversee and provide guidance on the Notary profession. The role of MPD is crucial in minimizing violations related to the Notary profession, particularly in Depok City. Therefore, it is necessary to examine the role of MPD in addressing violations of the Notary profession in Depok City, based on applicable regulations, as well as the implications of handling various types of violation reports submitted by the public on the performance of MPD in Depok City. This study uses a non-doctrinal method with qualitative empirical data, gathered through interviews and supported by secondary data. The research examines the performance of MPD's supervision in Depok City and its alignment with relevant regulations and theories. The findings of the study conclude that: (1) the role of MPD in addressing issues related to Notary violations in Depok City includes conducting investigations on the Notary in question based on violations found during protocol checks, public complaints, and unannounced inspections for Notaries who are frequently found to have committed violations in Depok City; (2) MPD Depok has made efforts to address each complaint report submitted between 2022 and 2024. However, there are still aspects that need evaluation, particularly regarding administrative order, the management of annual complaint data, and the transparency of the complaint data held by MPD Depok.
