Penelitian ini berfokus pada Penilaian Mantan Peserta Program *Criminon* dan *Therapeutic Community (TC)* tentang Efektifitas Pembinaan Rehabilitasi Penyalahgunaan Ulang Narkotika dengan membandingkan antara program *Criminon* dan *Therapeutic Community (TC)*. Penelitian ini adalah penelitian kuantitatif dengan desain deskripsi analisis. Penelitian ini bertujuan untuk menganalisis penilaian mantan peserta tentang efektifitas pembinaan dari program *Criminon* dan *Therapeutic Community (TC)*. Lebih lanjut penilaian mantan peserta tentang efektifitas yang dianalisis termasuk perbandingan dan frekuensinya terhadap pelaksanaan pembinaan *Criminon* dan *Therapeutic Community (TC)* dengan mengumpulkan data responden dari mantan klien masyarakat melalui pengambilan sampel secara aksidental. Hasil penelitian yang dilakukan, dapat diketahui bahwa tingkat penilaian mantan peserta tentang efektifitas pembinaan rehabilitasi penyalahgunaan ulang narkotika, berdasarkan asumsi penilaian mantan peserta *Criminon* dan *Therapeutic Community (TC)* bahwa efektifitas tertinggi pada program *Therapeutic Community (TC)*. Metode *Criminon* memiliki nilai rata-rata 3.207, sedangkan metode *Therapeutic Community (TC)* memiliki rata-rata nilai 3.376. Artinya bahwa perbandingan antara program *Criminon* dengan program *Therapeutic Community (TC)* tidak ada perbedaan yang signifikan dalam hal efektifitas pembinaan karena derajat signifikansi (0,109) lebih besar dari nilai alpha (0,025) dengan tingkat kepercayaan 95%. Dari analisis perbandingan dan frekuensi diperoleh rata-rata persentase penilaian mantan peserta tentang efektifitas pembinaan adalah sekitar 95% responden menyatakan sangat baik (sangat efektif) dan sekitar 5% menyatakan tidak baik.

Focus of this research is the analysis of effectiveness Assessment ex participants of treatment Criminon and Therapeutic Community (TC). Further, the effectiveness assessment were analyzed included comparation and frequency to treatment Criminon and Therapeutic Community (TC) which is by collecting of via questionnaire with acsidentail sampling. The research results are dislosed that the level of effectiveness assessment ex participants of treatment rehabilitation reprevention of narcotics, based on assumption assessment ex participants of Criminon and Therapeutic Community (TC) that effectivities cycle of Therapeutic Community (TC). Methode Criminon has mean score 3,207 methode Therapeutic Community (TC) has mean score 3,376. Meaning that comparation between programe Criminon with programe Therapeutic Community (TC) not difference that signification in many things effectiveness of treatment because degree of signification (0,109) more bigger than alpha (0,025) with level of confidence 95%. From comparative analysis and frequency get an average percentage of assessment ex participants about the effectiveness are around 95% respondents said very excellent and about 5% said is not good enough.
